# Crédit Agricole CIB appoints Patrick de Talancé as Senior Country Officer for Australia

Leveraging the full Australian banking licence the Bank acquired last year, Patrick will continue to expand the Bank's activities in Australia with a focus on transforming the well-established real asset financing platform into a fully-fledged corporate and investment banking set-up. Based in Sydney, he reports to Jean-François Deroche, Senior Regional Officer for Asia-Pacific at Crédit Agricole CIB.

He then moved to Houston to take up the role of Head of Energy North Americas in 2016. In 2020, he relocated to New York to take on the role of Chief Risk Officer for the Americas for Crédit Agricole CIB and the Crédit Agricole Group.
