In 2001, he returned to Spain as Head of Corporate Finance for Europe, and in 2009 he became Head of Corporate and Investment Banking for Europe. In 2010, he was appointed to lead the entire business line as Global Head of Banking & Corporate Finance until January 2021, when he became a Senior Advisor for the Santander Group.



Georg Orssich is an undergraduate at Vienna University in Business Administration and hold an executive programme from Stanford University.
